That's the reality for 92,000 people in Madison County who have little to no access to primary healthcare.

That's one reason Thrive Alabama became a community health center. Our growth from a small clinic serving a specialized community to a health center caring for patients from all walks of life has been part of a strategic plan to meet the healthcare needs of our exploding population. This expansion will also allow us to fill the gap for unnecessary and costly ER visits, thereby saving our larger healthcare system emergency care funds.

As a community health center, Thrive Alabama offers holistic healthcare services that include:

- Nutritional counseling



OUR STORY

or over 30 years, Thrive Alabama has played a vital role in North Alabama's health services landscape.

We currently have clinics in Huntsville, Florence, and Albertville that serve 12 counties.

1988 ■ A group of people responded to AIDS with love rather than fear and formed the AIDS Action Coalition of Huntsville (AAC). This band of volunteers provided food, assisted with rent, ran errands, paid utility bills, and, too often, helped people die with dignity.

1992 ■ AAC opened a clinic for people living with HIV and added much needed support services.

2000 ■ AAC received full funding from the Ryan White Care Act, a federal HIV/AIDS program, for \$325,000 allowing us to open more days in the clinic.

2015 ■ With patients responding well to medical advancements and living long, healthy lives, AAC began expanding services to people without HIV and changed its name to Thrive Alabama.

2018 ■ Thrive Alabama became a community health center and opened healthcare to people from all walks of life. We treat illnesses on an outpatient basis, often preventing chronic conditions from becoming more serious and expensive to treat.




